Our services include the full scope of protection services for children from prevention & early intervention to statutory intervention, care and reintegration. We follow a trauma-informed model of service.

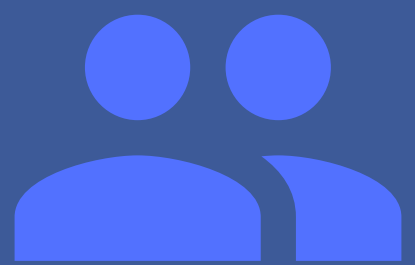

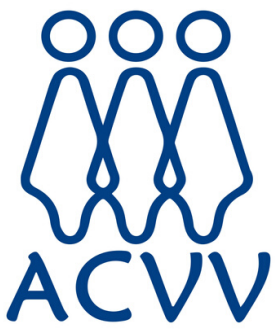

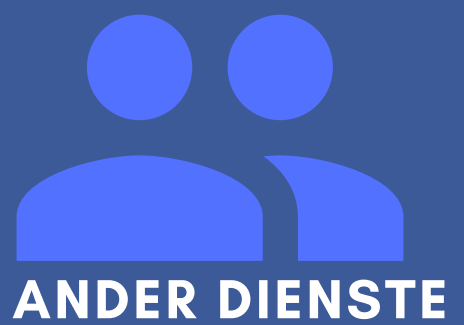
